Attached is the South Carolina BMP Courtesy Exam Log for June 2013. Twenty-one sites were closed out during the month. None of these sites were found to be out of compliance with applicable BMPs and no water quality impacts resulted from these forest operations.

For the sites reported this month, BMPs were properly applied by those responsible on thirteen sites, BMP Foresters provided recommendations to assist with compliance on seven sites, and remedial action was required on one site to achieve compliance.
