Attached is the South Carolina BMP Courtesy Exam Log for July 2011. Fourteen sites were closed out during the month. None of these sites were found to be out of compliance with applicable BMPs, and no water quality impacts resulted from these forest operations.

BMPs were properly applied by those responsible on nine sites reported this month. On the remaining exams BMP Foresters provided recommendations to assist with compliance on four sites, and requested additional action to achieve compliance on one site. In addition, thirteen compliance monitoring inspections were completed.
