Attached is the South Carolina BMP Courtesy Exam Log for July 2013. Twenty-five sites were closed out during the month. None of these sites were found to be out of compliance with applicable BMPs and no water quality impacts resulted from these forest operations.

For the sites reported this month, BMPs were properly applied by those responsible on nineteen sites, BMP Foresters provided recommendations to assist with compliance on five sites, and remedial action was required on one site to achieve compliance.
