Dear Sir or Madam:

Attached is the South Carolina BMP Courtesy Exam Report for July 2015. Twenty-three sites were closed out during the month. One site was found to be out of compliance with applicable BMPs.

Piedmont 2563 is a clearcut harvest in Spartanburg County rated unacceptable in the Streamside Management Zone (SMZ) category. An inadequate buffer with an average width of 15 feet was retained along approximately 640 feet of perennial stream. No in-stream water quality impacts were observed.

Of the twenty-two sites reported this month, BMPs were properly applied by those responsible on thirteen sites, BMP foresters provided recommendations during the operation to assist with compliance on six sites, a BMP forester noted deficiencies and requested additional action on site to achieve compliance on one site, and required remedial action or a return visit by the operator to bring the site into compliance was required on two sites.
