Attached is the South Carolina BMP Courtesy Exam Report for September 2018. Twenty sites were closed out during the month. None of these sites were found to be out of compliance with applicable BMPs and no water quality impacts resulted from these forest operations.

Of the twenty sites reported this month, BMPs were properly applied by those responsible on thirteen sites, BMP Foresters provided recommendations during the operation to assist with compliance on five sites, and the BMP Forester noted deficiencies and requested additional action to achieve compliance on two sites.
