Attached is the South Carolina BMP Courtesy Exam Log for October 2014. Thirty-seven sites were closed out during the month. None of these sites were found to be out of compliance with applicable BMPs and no water quality impacts resulted from these forest operations.

For the sites reported this month BMPs were properly applied by those responsible on twenty-seven sites, BMP foresters provided recommendations during the operation to assist with compliance on seven sites, and BMP foresters noted deficiencies and requested additional action on site to achieve compliance on three sites.
