Dear Sir or Madam:

Happy New Year. Attached is the cumulative South Carolina BMP Courtesy Exam Log for 2019. BMP Foresters closed out 193 sites during the year, representing 13,068 harvested acres, 28.64 miles of forested streamside management zones, and the protection of 37.5 total miles of stream.

Two sites had compliance issues and resulted in off-site water quality impacts. The remaining 191 sites were found to be in compliance with applicable BMPs. Of the sites reported, BMPs were properly applied by those responsible on 156 sites, BMP Foresters provided recommendations to assist with compliance on 29 sites, BMP Forester noted deficiencies and requested additional action on three sites to achieve compliance, three sites required a return visit from the operator to bring the site into compliance with BMPs and two sites were found to be out of compliance with applicable BMPs which resulted in in-stream water quality impacts and required remediation work. Overall, this results in a 99% compliance rate of those operations on which a BMP courtesy exam was conducted.
